

Immigration – Fees Structure

At Advice Wise Solicitors, we offer various immigration services to potential clients. Advice Wise Solicitors does not hold an Immigration Legal Aid Contract with the Legal Aid Agency and therefore all work carried out by Advice Wise Solicitors in relation to Immigration matters will be on a privately funded basis.

It is very difficult to provide an exact fee for all Immigration related matters and therefore to provide our clients with a guide as to the type of application/case, please see below a list of types of cases/applications that Advice Wise Solicitors can undertake and assist on a fixed fee arrangement.

Fixed Fee Arrangements

Should you wish to enter into a fixed fee for our services, we are able to accommodate the same. Our typical range of fees on a fixed fee basis are as follows:

Please note that the above fixed fee arrangements are a range only. Where the particular fee falls within the range depends on a number of factors such as the complexity of the matter, volume of preparation and the amount of work likely to be required. The fee will include work done by one Solicitor and one Caseworker (Trainee Solicitor, Paralegal or Legal Assistant).

Counsel's fees (a barrister) are likely to range from between $\pounds 300.00 - \pounds 1,000.00$ plus VAT per hearing/conference. The exact fees for Counsel are likely to depend on the seniority of Counsel, the amount of preparation required in your case and considering the likely length of any conference, appeal hearings or other such hearings.

The disbursements can range from travel costs to the need for any expert witnesses, such as doctors, interpreters, translators, other medical reports, estate agents overcrowding reports etc. Any travel on public transport will be claimed at the exact cost incurred. Any travel by car will be claimed at 45p per mile, which will be subject to VAT. It is not possible to provide a range of costs for any expert witnesses as the cost will vary depending on the type of expert required and the scope of the work given. It is likely that most disbursements would be subject to VAT.

However, in the event that you would prefer to instruct Advice Wise Solicitors on an hourly basis, then the following will apply:

Hourly Rate Fees

We are able to enter into hourly rate fees with you. Our hourly rates are as follows:

The above is an indication of our fees. The hourly rates will be applied to all work carried out by us to prepare your case. This includes considering evidence, taking statements from you and/or drafting statements, preparing your case, liaising with you, the Home Office, the Tribunal, Embassy and others. The above will be **excluding** any costs for Counsel's fees or disbursements.

Counsel's fees (a barrister) are likely to range from between $\pounds 300.00 - \pounds 1,000.00$ plus VAT per hearing/conference. The exact fees for Counsel are likely to depend on the seniority of Counsel, the amount of preparation required in your case and considering the likely length of any conference, appeal hearings or other such hearings.

The disbursements can range from travel costs to the need for any expert witnesses, such as doctors, interpreters, translators, other medical reports, estate agents overcrowding reports etc. Any travel on public transport will be claimed at the exact cost incurred. Any travel by car will be claimed at 45p per mile, which will be subject to VAT. It is not possible to provide a range of costs for any expert witnesses as the cost will vary depending on the type of expert required and the scope of the work given. It is likely that most disbursements would be subject to VAT.
